CLASSIFICATION OF SERVICES

The System of Public Bikes must provide monthly a network of stations and bicycles, that will extend itself to the downtown area of the City, as well as other areas that are of interest to **URBES**. These areas correspond to:

- a) 25 (twenty-five) stations;
- b) 200 (two hundred) operating bikes; and
- c) 20 (twenty) bicycles as technical reserves.

The “technical reserves” will be used every time that maintenance and substitutions will be made necessary, guaranteeing that an operational reserve is sustained.

The Public Bicycles System will work daily between 7am and 10pm for bikes withdrawal/users rent and 24hrs for return of bicycles.
